### **Project Information**

The Council District 7 (Sylmar, Mission Hills, North Hills & Pacoima) Streetbox project has been made possible through a partnership with Council Member Monica Rodriguez. This Project transforms 38 utility boxes within Council District 7 into works of art.

### **Theme**

"Social Justice"  
"Native Lands"  
"The Arts"

## **Submission Deadline: July 10th @ midnight**

Designs by artists who are residents of the Sylmar, Mission Hills, North Hills and Pacoima will be given priority.

Artists are encouraged to create designs highlighting a modern, colorful aesthetic, diversity and unity throughout our community.

### **Artist Compensation and Commitment**

Chosen renderings/artists will be given a stipend of \$750 USD to complete their works of public art and maintain the integrity of the work for a period of 2 years. Artists will be responsible for all of the necessary materials required for preparation, completion and maintenance of the artwork.

### **Eligibility**

This project is open to all artists in the Greater Los Angeles area. Street Box encourages applications from both new and established artists as well as students.

- Artists may apply as an individuals or as a group.
- Group submissions may be for a single utility box or multiple utility boxes.

### **Selection Process & Criteria**

Submissions will be reviewed by a selection committee consisting of Street Box curators, community members and City representatives. Once the artwork is selected, the committee will send a notification by email and formal letter and the artist(s) will be assigned the City utility box(es).

### **Criteria used to select artists will be:**

- Evaluation of artistic excellence including quality of the art and artist originality;
- Creative and innovative concepts in relationship to the theme;
- Appropriate regard for the nature of the space and the audience.

### **Specifications**

Street Box Art is designed to encourage community pride and beautify the neighborhood. Street Box Art will be installed in a public place and must be suitable for viewing by all ages. If your designs is chosen, the artwork that is submitted in this application will be the artwork painted on the utility box. Designs may not change without a new rendering being submitted.

### **A Proposal will be ineligible, for any one or more of the following reasons:**

- If it contains copyrighted or trademarked image or logo; a brand or business name;
- Is plagiarized, stolen, or copied from another source;
- Defames or invades the rights of any person, living or dead;
- Is likely to incite or produce an imminent lawless act;
- Is integral to criminal conduct or violates the law;
- Collage work requiring anything to be glued onto the box;

**Submission Deadline: July 10th @ midnight**

- May reasonably be construed as false or fraudulent; obscene matter, as defined in California Penal Code Section 311 or any successor legislation; harmful matter for minors, as defined in California Penal Code Section 313 or any successor legislation.

Incomplete applications will result in disqualification.**

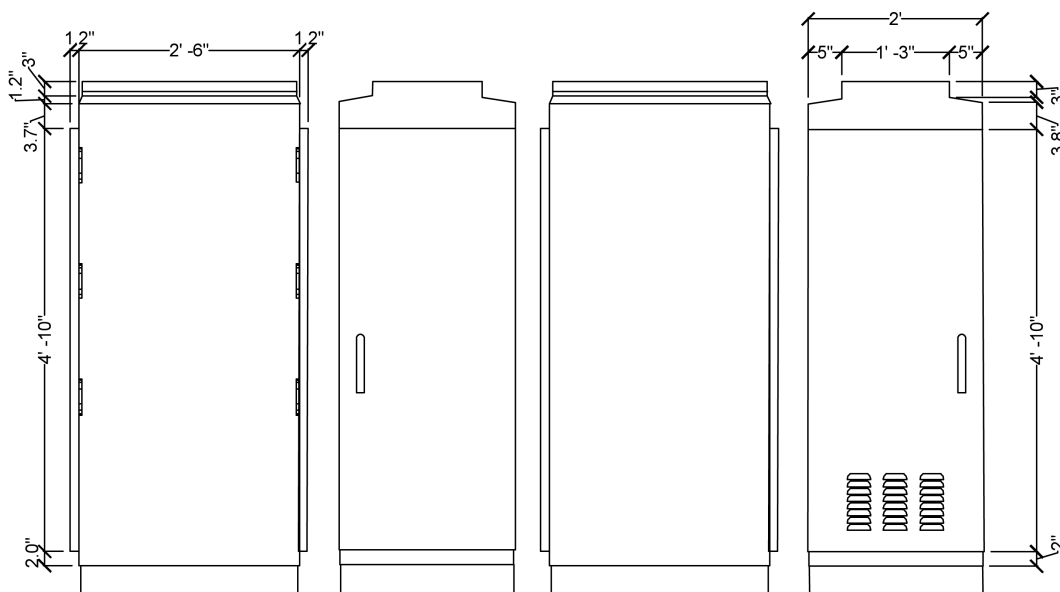
- The signed contract and liability waiver.
